Pursuant to the said directions (a) separate meetings of the equity shareholders and the unsecured creditors of the Company were convened; and (b) the meeting of secured creditors of the Company was dispensed with by NCLT Mumbai in view of the consent affidavits of the secured creditors submitted by the Company. Post such approvals, a joint Company Scheme Petition was filed with NCLT Mumbai for its approval on the Scheme. The said Petition vide NCLT Mumbai's Order dated April 28, 2023 has been admitted for final hearing.
15. The Company has not accepted / renewed / repaid any amount which comes under purview of the term "Deposit" as per Companies (Acceptance of Deposit) Rules, 2014 during the financial year 2022-23;



16. The Company has borrowed funds from Banks and complied with the provisions of the Act including creation, modification and satisfaction of charges, wherever applicable.
17. The Company has complied with the provisions of Section 186 of the Act.
18. The Company has not altered its Articles of Association and Memorandum of Association.
