## Sub: Update on Credit Ratings - Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

In accordance with Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to apprise about the credit ratings assigned / reaffirmed by ICRA Limited ('**ICRA'**) to the Company's facilities / instruments.

In accordance with the Composite Scheme of Arrangement amongst the Company ('Demerged Company'), Klass Pack Limited (renamed as 'Borosil Scientific Limited') ('Resulting Company') and Borosil Technologies Limited ('Transferor Company') and their respective shareholders and creditors ('Scheme'), sanctioned by the Hon'ble NCLT, Mumbai Bench, on November 02, 2023, the Company's Scientific and Industrial Products business stands demerged and transferred into the Resulting Company with effect from the Effective Date i.e. December 02, 2023. The Company continues to operate its Consumer Products ('CP') business and, ICRA anticipates that the Company's overall credit profile is expected to remain Stable.

Rating placed on watch with developing implication has been removed and Stable outlook has been assigned / ratings have been reaffirmed in view that the Company's credit profile would continue to benefit from its established brand. ICRA has also assigned Stable outlook for the enhanced limits.
